Animals may act in sudden, unpredictable, and potentially dangerous ways especially when startled, injured, or under duress.

WARNING: PARTICIPATION AT YOUR OWN RISK

- I understand that serious INJURY, DEATH, OR PROPERTY DAMAGE may result from participation in rodeo or associated activities and events. By signing this waiver, I acknowledge that I am voluntarily participating at my own risk.

DISCLAIMER OF LIABILITY

- I agree that I, the undersigned, PARTICIPATE AT MY OWN RISK. The National Rodeo Council of Australia Ltd (NRCA) and their Directors, Member Associations, Affiliated Committees, Organisers, Schools, Members, Officers, Officials, Stock Contractors, and Employees shall not be liable for any personal injury, economic loss, nervous shock, property damage, or any other loss or damage I may suffer arising from my participation in events organised or affiliated with the NRCA. This disclaimer applies to any liabilities arising from express or implied terms of participation, common law, statutory law, or otherwise.

CONDUCT DURING PARTICIPATION:
